**RELEASE WAIVER FOR LIABILITY AGREEMENT FOR ADULT PARTICIPANTS/FITNESS ROOM**

### ~General information~

1. Members must meet the age requirement to join NSC . ( Stated on the membership application).
2. Members must be self sufficient , physically, mentally , emotionally and require no assistance when it comes to personal care. ( Medication, Restrooms assistance and other individuals needs )
3. Members must have the ability to safely navigate around the facility and trip destinations unassisted. Unless participant is accompanied by a companion or aide to escort them at all times.
4. Members must follow all safety procedures in the facility and on the vehicles providing transportation.
5. Inappropriate language , body gestures will not be tolerated in any of our social settings.
6. NSC reserves the right to notify appropriate agencies for immediate intervention .
7. Member must not pose any risk to themselves or others , all action will be reported .
8. No soliciting or panhandling is allowed on the property of NSC.
9. All participants must complete an application form , and obtain a membership card at the reception desk and the card must be used to sign in and out at each visit.
10. Designated areas are for staff members only, unless given permission . ( kitchen, offices, closest etc..)
11. No animals are allowed unless they are a Service Animal ( as defined by federal and state Laws) may enter the Senior Center and must be restrained and under the supervision of their companion or owner at all times. Animals must not be left unattended outside the Senior Center.
12. All surveys, pictures, videos, etc., becomes the property of NSC, unless written permission of the Director has been granted.
13. Blocking or obstructing entrances, exits, outside sidewalks or walkways is not allowed at any time.
14. Violation of the NSC Codes of Conduct or General Facility Rules may result in disciplinary action, including suspension from the Center.
15. NSC is not responsible for any personal items that have been brought to the Center.
16. Change of address, phone number or emergency contacts should be changed when dues are paid.

17. NSC does not tolerate any illegal activities in the Center.

19. Maintain a level of personal hygiene consistent with generally accepted standards of health and safety for themselves and others.
